
Gloucestershire Primary Care Network (PCN) Newsletter

Actions for this month:

PCN Development Funding: The PCN Team has sent out an <u>email</u> for PCN's to complete the template outlining their proposals for utilising the 22/23 PCN Development Funding, in line with the requirements and have returned by **COP 25**th **November** to the PCN Inbox (<u>glicb.PCN@nhs.net</u>)

Review ARR Claims: Please can PCNs review their ARR claims for this financial year ahead of year end to ensure they are up to date and accurate.

NWRS: Please can PCNs login into the NWRS system, review and, if required, update your workforce data ensuring it matches ARR claims. PCN staff are required to be recorded, including CDs. Further guidance available here

Latest Updates:

PCN Finance Descriptions:

The PCN Team recently circulated to all PCN Clinical Directors and Business Managers an updated PCN Finance Descriptions document to reflect the changes to the 22/23 Network Contract DES NHSE/I released in September 2022. The document gives an overview of the funding streams which link to PCNs (via the Network DES or local/other funding).

Proactive Social Prescribing (Personalised Care) Requirements:

PCNs are reminded of the Proactive Social Prescribing element (Personalised Care) in the PCN Network Contract DES. From 1 October 2022, a PCN must commence delivery of the proactive social prescribing service for the identified cohort and by 31 March 2023, a PCN must review cohort definition and extend the offer of proactive social prescribing based on an assessment of the population needs and PCN capacity.

Caring for yourself and others with compassion: e-learning now available:

Following a pilot, the HEE 'Handling difficult situations – Caring for yourself and others with compassion' training is now available for all patient-facing NHS colleagues, including all patient-facing colleagues working across primary care, either in non-clinical or clinical roles. The e-learning aims to upskill colleagues in how to handle difficult situations with compassion, using appropriate communication techniques and active listening skills, whilst focusing on how to keep yourself well if you feel affected by a situation.

 Although some PCNs may choose to use paramedics as part of a home visiting service, other tasks may include:
 - Managing patients with acute presentations in a surgery clinic
 - o Triaging
 - o Care homes
 - Long term condition management and health promotion (with appropriate training)
