
Gloucestershire Primary Care Network (PCN) Newsletter

Actions for this month:

Review ARR Claims: Please can PCNs review their ARR claims for this financial year ahead of year end to ensure they are up to date and accurate. There are upcoming changes to the ARRs portal to link with PCSE, the PCN Team are awaiting further details from NHSE/I & PCSE and will share as soon as possible.

Update NWRS data: NHS Digital extract the GP and PCN workforce data from the <u>National Workforce Reporting Service</u> (<u>NWRS</u>) at the end of each month. Please continue to log into <u>accounts</u> at least monthly, to check / update workforce details as necessary. This should include all ARRS staff, including any changes to working hours including overtime.

CQRS Reminder: CQRS accounts will disable after 90 days of no activity – this means, if a user has not logged into CQRS for 90 days, their account will automatically disable to keep the account secure. If you need your CQRS account reset, please contact the PCN team via the PCN mailbox.

Proactive Social Prescribing (Personalised Care): We would like to remind all PCN's that they must review their cohort definition and extend the offer of proactive social prescribing based on an assessment of the population needs and PCN capacity.

Community Pharmacist Consultation Service New Resources -

Changes to ARRS and GP Contract

Changes to the ARRs scheme in 23/24 have been announced by NHSE (please see letter <u>here</u>), this includes:

- Increasing the cap from 2 to 3 advanced practitioners per PCN with a list size of 99,999 or fewer (applicable to all Gloucestershire PCNs)
- Advanced clinical practitioner nurses have been added to the eligible roles under ARRs, as advanced practitioners

We are awaiting full details of this, however, now might be a better time than ever if you or your primary care employer are considering advanced practice. Please note the funding is annual, so the next opportunity will not be until Feb/March 2024.

In addition to the above, Mental Health Practitioners (MHPs) are also referenced in the NHSE letter, with the previous cap on numbers a PCN could have in post being lifted entirely. We are in discussions with our partner in this programme, GHC, to progress the recruitment for those PCN's wishing to recruit a second MHP. Further updates on this to follow shortly.

Acknowledging the benefits that Physicians Associates (PAs) have had in general practice, the changes to the GP contract confirms that apprenticeship PA's are now a reimbursable role under ARR's.

SPOTLIGHT ON ARRs – Podiatrists

We are shining a spotlight on individual ARRs roles within the PCN newsletter, in a series of bite sized briefings. Our next spotlight role is Podiatrists.

Did you know that Podiatrists in Primary Care can cover the below areas and more?

- Early identification of problems to prevent chronic foot health issues
- Specialist knowledge of foot and ankle health across a wide range of clinical presentations including MSK, cardiovascular, neurological, dermatological or age-related conditions
- Depending on experience and training, FCP podiatrists can request and interpret a range of diagnostic tests (this can include X-rays where local permissions are in place)
- Formulate treatment plans
- Depending on experience and training some can preserve foot and ankle function, reducing the risk of immobility
- Preserve foot and ankle health, reducing the risk of wounds, infection, or amputation
- Support identification and management of Peripheral Arterial Disease
- Work as part of a multi-disciplinary team (MDT)
